Clean the entire area with close high pressure fresh water washing using a fan-jet lance held close to the surface (3,000 p.s.i., 211 kg/cm²) as soon as the vessel enters dock and before it dries out. Consult International Paint for alternative methods of surface preparation. Repair corroded areas with the recommended anticorrosive primer system and apply Interclene 155 within the overcoating interval specified for the primer (consult relevant primer data sheets).

On immersion Interclene 155 lightens in colour.
